



## Adobe® Experience Manager (AEM) 6.2 Forms - Server Administration Voluntary Product Accessibility Template

The purpose of the Voluntary Product Accessibility Template is to assist Federal contracting officials in making preliminary assessments regarding the availability of commercial Electronic and Information Technology products and services with features that support accessibility. It is assumed that offerers will provide additional contact information to facilitate more detailed inquiries.

The first table of the Template provides a summary view of the section 508 Standards. The subsequent tables provide more detailed views of each subsection. There are three columns in each table. Column one of the Summary Table describes the subsections of subparts B and C of the Standards. The second column describes the supporting features of the product or refers you to the corresponding detailed table, “e.g., equivalent facilitation.” The third column contains any additional remarks and explanations regarding the product. In the subsequent tables, the first column contains the lettered paragraphs of the subsections. The second column describes the supporting features of the product with regard to that paragraph. The third column contains any additional remarks and explanations regarding the product.

(a) When software is designed to run on a system that has a keyboard, product functions shall be executable from a keyboard where the function itself or the result of performing a function can be discerned textually.	<b>Supports with exceptions</b>	<p>Most functions in the AEM Forms Server Administration interface are fully operable using a keyboard alone with some exceptions, including:</p> <p>It is not possible to order ascending/descending table row data in the Role Management section.</p> <p>Widgets in the Search Template Definition sections are not fully keyboard accessible.</p> <p>The hide/show details and 'add new calendar' button in the Business Calendars screen in the Process Management section cannot be operated using the keyboard.</p>
(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. Applications also shall not disrupt or disable activated features of any operating system that are identified as accessibility features where the application programming interface for those accessibility features has been documented by the manufacturer of the operating system and is available to the product developer.	<b>Supports</b>	AEM Forms Server Administration does not interfere with or deactivate accessibility features of any operating system.
(c) A well-defined on-screen indication of the current focus shall be provided that moves among interactive interface elements as the input focus changes. The focus shall be programmatically exposed so that Assistive Technology can track focus and focus changes.	<b>Supports</b>	<p>There is a visual indication of focus for all focusable elements in the AEM Forms Server Administration interface.</p> <p>Focus is programmatically exposed for focusable elements in the AEM Forms Server Administration interface.</p>

(d) Sufficient information about a user interface element including the identity, operation and state of the element shall be available to Assistive Technology. When an image represents a program element, the information conveyed by the image must also be available in text.	<b>Supports with exceptions</b>	<p>Some controls in the AEM Forms Server Administration interface do not provide sufficient information to Assistive Technology. For example:</p> <p>The Business Days checkboxes and 'add new calendar' button in the Business Calendars screen do not provide sufficient information.</p> <p>The checkboxes in the Archive Management screen do not provide identity information.</p> <p>The controls in AEM Forms Forms area of the Services section do not provide identity information.</p> <p>Controls in the AEM Forms Server Administration installer and Configuration Manager application do not provide sufficient information.</p>
(e) When bitmap images are used to identify controls, status indicators, or other programmatic elements, the meaning assigned to those images shall be consistent throughout an application's performance.	<b>Supports</b>	
(f) Textual information shall be provided through operating system functions for displaying text. The minimum information that shall be made available is text content, text input caret location, and text attributes.	<b>Supports with exceptions</b>	With the exception of text in inputs in the installer and Configuration Manager application, text information is provided through operating system functions for displaying text and is available to Assistive Technology.
(g) Applications shall not override user selected contrast and color selections and other individual display attributes.	<b>Supports with exceptions</b>	The AEM Forms Server Administration interface supports Windows High Contrast Mode, except for the Configuration Manager application and Flex components such as the Business Calendars interface.

(h) When animation is displayed, the information shall be displayable in at least one non-animated presentation mode at the option of the user.	<b>Supports</b>	AEM Forms Server Administration uses only basic animation in the user interface. Information is displayed in a non-animated presentation mode.
(i) Color coding shall not be used as the only means of conveying information, indicating an action, prompting a response, or distinguishing a visual element.	<b>Supports</b>	The AEM Forms Server Administration user interface does not use color as the only means of conveying information.
(j) When a product permits a user to adjust color and contrast settings, a variety of color selections capable of producing a range of contrast levels shall be provided.	<b>Not applicable</b>	AEM Forms Server Administration does not permit the user to adjust color and contrast settings.
(k) Software shall not use flashing or blinking text, objects, or other elements having a flash or blink frequency greater than 2 Hz and lower than 55 Hz.	<b>Supports</b>	AEM Forms Server Administration does not use flashing or blinking text, objects, or other elements in the software's user interface.

(b) Equivalent alternatives for any multimedia presentation shall be synchronized with the presentation.	<b>Not applicable</b>	The AEM Forms Server Administration interface does not include multimedia.
(c) Web pages shall be designed so that all information conveyed with color is also available without color, for example from context or markup.	<b>Supports</b>	The AEM Forms Server Administration interface supports this requirement.
(d) Documents shall be organized so they are readable without requiring an associated style sheet.	<b>Supports</b>	The AEM Forms Server Administration interface supports this requirement, but the usability of the interface is degraded.

(b) At least one mode of operation and information retrieval that does not require visual acuity greater than 20/70 shall be provided in audio and enlarged print output working together or independently, or support for Assistive Technology used by people who are visually impaired shall be provided.	<b>Supports</b>	
(c) At least one mode of operation and information retrieval that does not require user hearing shall be provided, or support for Assistive Technology used by people who are deaf or hard of hearing shall be provided	<b>Supports</b>
